In the name of God Amen I Daniel Woolgar of the parish of Stoke next Guildford in the County of Surrey Currier who am in health and of sound and disposing mind memory and understanding First I commend my soul unto the hands of Almighty God who gave it and my body I commit to the Earth to be decently and frugally interred at the discretion of my Executor and Executrixes hereinafter named And as to all my Worldly Estate whatsoever and wheresoever wherewith it has pleased God to bless me I give devise and bequeath the same after payment of my Funeral expences the expense of proving this my Will and all my just Debts as hereinafter is mentioned vizt I give and devise unto my Son William Woolgar his heirs and assigns All that my Messuage or Tenement with the Buildings Garden and Appurtenances thereunto belonging situate standing and being in a Street commonly called Spital Street in the parish of Stoke next Guildford in the said County of Surrey now in my own occupation to have and to hold the same unto and to the use and behoof of my said son William Woolgar his heirs and assigns for Ever Also I give and devise unto my Daughter Elizabeth the Wife of George Wigman and my Daughter Martha Woolgar and their heirs All those my three undivided fourth parts or shares the whole into four equal parts to be divided of and in all those two Messuages or Tenements with the Buildings Gardens and Appurtenances thereunto belonging situate standing and being in the said Street called Spital Street in the said parish of Stoke next Guildford now in the several tenures or occupations of Thomas Soutton and Charles Spice to have and to hold the said three undivided fourth parts or shares of and in the said Messuages or Tenements Buildings and Gardens with the Appurtenances unto and to the only use and behoof of my said daughters Elizabeth the Wife of George Wigman and Martha Woolgar equally to be divided between them share and share alike as tenants in common and not as joint Tenants and to their respective heirs and Assigns for Ever And I give and bequeath unto my said son William Woolgar and my said Daughters Elizabeth the Wife of George Wigman and Martha Woolgar All my Leasehold Messuages or Tenements Goods Furniture Stock in Trade Monies

Securities for money and Personal Estate and Effects whatsoever and wheresoever equally to be divided between them share and share alike to and for their own use and benefit and to their respective Executors Administrators and Assigns and I nominate constitute and appoint my said son William Woolgar and my said Daughters Elizabeth the Wife of George Wigman and Martha Woolgar Executor and Executrixes of this my Will In Witness whereof I the said Daniel Woolgar have to this my last Will and Testament set and subscribed my hand and Seal the eleventh Day of April in the year of our Lord One Thousand eight hundred and seven Daniel Woolger (L:S) signed sealed published and declared by the said Testator Daniel Woolgar as and for his last Will and Testament in the presence of us, who at his request and in his presence and in the presence of each other have hereunto subscribed our names as Witnesses James Douglas Joseph Hockley Joseph Hockley Jr.

This is a Codicil to be added to and taken as part of the last Will and Testament of me Daniel Woolger above written Whereas I have in and by my said Will given and bequeathed unto my son William Woolger and my Daughters Elizabeth the Wife of George Wigman and Martha Woolger All my Leasehold Messuages or Tenements equally to be divided between them share and share alike Now I do hereby revoke the bequest of my Leasehold Messuage or Tenement situate lying and being in the Parish of Holy Trinity in Guildford in the County of Surrey now in the occupation of my son William Woolger And I give and bequeath the same Messuage or Tenement with the Appurtenances for and during all the rest residue and remainder of my Term Estate and interest therein and thereto unto my said daughter Martha Woolger her Executors Administrators and Assigns to and for her and their own use and benefit And I ratify and confirm my said Will in all other respects except as hereby altered In Witness whereof I have hereunto set my hand and Seal the twenty fourth Day of September in the year of our Lord One thousand eight hundred and eleven Daniel Woolger (LS) signed sealed published and declared by the said Daniel Woolger the Testator as and for a Codicil to be added to and taken as part of his last Will & Testament in the presence of us who in his Presence at his request and in the presence of each other have hereunto subscribed our names as Witnesses Joseph Hockley Joseph Hockley Jr. William Tayler Jr.

PROBATE granted 02 January 1819

This Will of Daniel Woolger late of Stoke next Guildford in the County of Surry deceased was proved on the second Day of January 1819 before the Reverend William Hodgson Cole Clerk a Surrogate by the Oaths of William Woolger in the Will written Woolgar the son of the deceased and Elizabeth Wigman the Wife of George Wigman and Martha Woolger Spinster in the Will written Woolgar the daughters of the deceased the Executors to whom Administration was granted they having been first sworn duly to Administer
